

AFTER SCHOOL INFORMATION SHEET

Welcome to Proehlific Park's After School Program. We are excited to have your child enrolled in our program. Proehlific Park is devoted to character building through academics, enrichment activities, fellowship and athletics. We're the most affordable and the best After School Program in Guilford County.

Ages: Children in 2nd Grade (or 7 years old) – 8th Grade

Program Hours: **During the Academic School Year** - 2:30 pm - 6:30 pm, M – F (Early Release Days, Teacher Work Days and Holiday Child Care is available at additional cost or included in Platinum Program)

Transportation Options:

- **Guilford County School Bus Drop-Off From:** Claxton Elementary, Kernodle Middle School, Western Guilford H.S. Pearce Elementary & Summerfield Elementary have provided 20 spots for the past two school years but we can't guarantee. Bus transportation is also provided from magnet schools per parent requests.
- **Van Pick Up From:** Jesse Wharton Elementary, Jefferson Elementary, GSO Montessori and Greensboro Academy *Spaces are limited on the van, please make sure there is a space available prior to signing up for after school program. Additional Fee of \$30/month for van pick up.*

A Typical Day in After School Care at Proehlific Park: Please note that all after school students are encouraged to use our computer lab for research & homework assignments. All students are allowed to complete their homework assignments if they need more than the scheduled time & will be supervised.

Elementary School Children:

2:45 - 3:00 pm: Arrival, check-in with ID cards and free play with coaches.

3:00 - 4:00 pm: *Grades 2 & 3:* Homework Huddles with coach assistance. Coaches check assignment journals/folders & completed homework.

Grades 4 & 5: Snack time & organized activities on basketball courts, indoor turf field, batting cages, outdoor sports on baseball and soccer fields, and playground fun.

4:00 - 5:00 pm: *Grades 2 & 3:* Snack time & organized activities on basketball courts, indoor turf field, batting cages, outdoor sports on baseball and soccer fields and playground fun.

Grades 4 & 5: Homework Huddles with coaches assistance. Coaches check assignment journals/folders and completed homework

5:00 - 6:30 pm: Recreational and enrichment activities available: Arts and crafts, computer skills, dance classes, multi-sport skill building and much more. **Recreational and enrichment activities will vary from day to day*

Middle School Youth:

3:15 - 4:15 pm: Arrival, check-in with ID cards.

3:15 - 4:30 pm: Snack and Homework Huddle with coach assistance on our mezzanine and in our Academic Success Center. *(If extra time is needed, coaches stay with those students until they complete their assignments).*

4:30 - 6:30 pm: Students enjoy court, turf, enrichment activities of choice with coaches.

**Please make sure your child has school supplies. The park is not responsible for supplying pencils, calculators, paper, etc.*

After School Program Membership Descriptions

NEW - Platinum After School Program: \$229 Member / \$249 Non-Member per month (pro-rated first month)

Includes: One-time monthly charge includes M-F After School Care until 6:30 pm; also includes ALL Early Release Days, Teacher Work Days, Inclement Weather Days and most Holidays (Proehlific Park does close as a business during certain holidays). Days when school is closed for the entire day, Proehlific Park Extended Day Coverage is from 7:30 am-6:30pm.

Regular After School Program: \$189 Member / \$199 Non-Member per month (pro-rated first month)

Includes: Monday – Friday After School Care until 6:30 pm. **Does NOT** include Early Release Days, Teacher Work Days, Inclement Weather Days and Holidays – those are available for additional cost.

Holiday/Vacation Day Policies and Prices for After School Program Members

Proehlific Park makes all attempts to be open on the days Guilford County Schools are closed for vacations, teacher work days and inclement weather. We will post early openings for children on our website as soon as a decision is made. Please visit our website to register for these days and view updates on inclement weather opening times.

During Inclement weather, we will open at 8:00 a.m. or if later, it will be announced on news channels and our website.

\$25 Full Day care (7:30 am – 6:30 pm)

\$15 Half Day (Early Release) care (7:30 am – 1:00 pm or 1:00 pm – 6:30 pm – 5 1/2 hours)

Your child is welcome to bring a friend. Fees for guests to join the “After School” program are on our website.

AFTER SCHOOL AGREEMENTS & WAIVERS

AFTER SCHOOL FINANCIAL AGREEMENT

It is my understanding that:

- Terminations and changes to monthly after school membership require a 2 WEEK written notice.
- All registration fees are non-refundable.
- After School Members shall not be relieved of his/her obligations to make payments agreed to, and no deduction from any payments shall be made because of participant's failure to use Proehlific Park facilities.
- Errors or questions regarding the draft should be addressed to the member services office as soon as possible. Any errors must be identified NO LATER THAN 60 DAYS from the posted bank statement. Proehlific Park DOES NOT accept responsibility for any errors; if MORE THAN 90 DAYS have past since the initial error.
- Proehlific Park Board of Directors may, at their discretion, adjust the monthly membership rate application to my category membership. I understand that I will receive at least 30 days notice of the change before a debit occurs at the new rate.
- Should my bank or credit card company for any reason not honor any monthly draft, I realize that I am responsible for that payment plus a \$25 service charge applied by Proehlific Park. This is in addition to any service fee my bank may charge.
- All balances outstanding for 30 days are subject to a monthly service charge. Any unpaid balance for membership fees, goods or services past 30 days may result in automatic suspension of facility privileges.

Additional Fees:

- After School dismissal time is 6:30pm M-F and I will be charged \$1.00 per minute after 6:30pm for late pickup.
- I understand that all after school members must check-in and check-out with the front desk with their after school membership card upon arriving and leaving Proehlific Park. If my child does not have their membership card upon arrival a \$1.00 will be charged to my credit card or bank account.
- Fee for reprinting a new card is \$5.00.
- Proehlific Park offers Extended Day Coverage 8:00am-6:00pm for all Guilford County School Holidays / Teacher Work Days / Early Release Days. It is my understanding that any time my child is at Proehlific Park prior to 2:30pm there will be a charge associated with that day unless my child is a part of the Platinum Program. For a list of Extended Day Fees and Times please visit our website www.proehlificpark.com. I acknowledge that if my child attended an extended day and payment is not made prior to the day of service these fees will be charged to my account.

PROEHLIFIC PARK GENERAL WAIVER

It is my understanding that:

- As an After School member I will adhere to the values of Proehlific Park while participating in any Proehlific Park program. Failure to do so may result in my after school membership privileges being revoked.
- I understand that all after school members must check-in and check-out with the front desk with their after school member card upon arriving and leaving Proehlific Park.
- It is my responsibility to contact my child's physician before beginning any activity.
- In the event of a medical emergency; I authorize Proehlific Park employees to take the necessary steps regarding medical attention (i.e. first aid, calling EMS or transportation to be admitted to the hospital) and will allow authorized hospital facilities and staff to treat me or my child for any illness or injury he/she has. Also, that I will be financially responsible for any expenses involved.
- I give my permission to have my child's photo taken while participating in activities at Proehlific Park. I further acknowledge that these photos may be used in advertising and marketing materials and hereby release all such photos to be used for promotion of Proehlific Park at the will of Proehlific Park.
- All activities involve certain inherent risks. Regardless of the care taken, it is impossible to ensure the safety of all participants. Proehlific Park activities require coordination, balance and athletic skill. While Proehlific Park uses care in conducting all programs, it is unable to eliminate all risk from activity.
- It is possible for participants to suffer common injuries such as muscle strains and sprains. More serious, but less frequent, injuries such as broken bones, cuts, concussions, paralysis and death may also occur. These injuries, and others, may result from such incidents as (but not limited to) slips and falls, tripping, colliding with another child or equipment, and stress placed on the skeletal system.

AGREEMENT TO PARTICIPATE

In further consideration of being permitted to enter Proehlific Park for any purpose, including but not limited to observation or use of facilities or equipment or participation in any programs affiliated with Proehlific Park, without respect to location, I agree to the following:

- I have read and agree to follow safety rules, all posted safety rules and all rules common to athletics.
- I agree to report any unsafe practices, conditions or equipment to management.
- I possess a sufficient degree of skill and physical fitness to safely participate in physical activity.
- I understand that I am to discontinue any time I feel undue discomfort or stress.
- I will indicate below any health-related conditions that might affect my ability to participate.
- I will verbally inform activity management immediately of any health condition that will affect my physical activity.

WAIVER OF LIABILITY

It is understood that the use of the facilities and or the participation in sports activities at Proehlific Park may involve the risk of serious injury or death. I expressly agree that all such activities and or the use of the facilities shall be undertaken at my own risk. I represent that I am or my minor child is physically able to undertake all physical activities provided by Proehlific Park and Proehlific Sports Inc. In consideration of above minor participant being permitted to participate in Proehlific Park and in activities at Proehlific Park, the undersigned parent(s) or guardian, on behalf of the parent, parent's heirs, parent's personal representatives or assigns, do hereby forever release, waive, discharge and covenant not to sue Proehlific Sports Inc. (including its officers, directors, employees, affiliates, independent contractors, coaches, and volunteers) from liability for any and all claims, demands, injuries, actions, active or passive negligence or other causes or actions whatsoever arising out of or connected with the use of any of the services or facilities provided by Proehlific Sports Inc. and/or Proehlific Park that the parent/guardian might have arising from injury or loss to said minor, whether due to the negligence of Proehlific Sports Inc. or otherwise. Proehlific Sports Inc. shall not be liable for any such claims. Participant's parent, participant's legal guardian, or I hereby consent and affirm the foregoing Liability Waiver on behalf of participant, participant's family and all other parties stated. By affirming and consenting to the liability waiver of risk agreement, it is my intention that terms of the document by and through my consent are as effective as if the participant were an adult rather than a minor.

I have read the preceding information and my questions have been answered. I know, understand and appreciate the risks associated with playing sports and physical activity, and I am voluntarily participating in the activities provided at Proehlific Park and/or Proehlific Sports Inc. In doing so, I am assuming all of the inherent risks of the sport.

The undersigned hereby irrevocably consents to and authorizes the use by Proehlific Sports, Inc. and The POWER of Play Charitable Fund, Inc., their officers, directors and employees of the undersigned's image, voice and/or likeness as follows: Proehlific Sports, Inc. and The POWER of Play Charitable Fund, Inc., shall have the right to photograph, publish, re-publish, adapt, exhibit, perform, reproduce, edit, modify, make derivative works, distribute, display or otherwise use or reuse the undersigned's image, voice and/or likeness in connection with any product or service in any and all markets, media or technology now known or hereafter developed. Proehlific Sports, Inc. and The POWER of Play Charitable Fund, Inc. may exercise any of these rights themselves or through any successors, transferees, affiliates, licensees, distributors or other parties, whether commercial or noncommercial. The undersigned acknowledges receipt of good and valuable consideration in exchange for this Release, which may simply be the opportunity to represent Proehlific Sports, Inc. and/or The POWER of Play Charitable Fund, Inc., in its promotional and advertising materials as described above.

BEHAVIOR EXPECTATION

It is important that staff maintain good order and discipline in all programs. Top objectives in all Proehlific Park programs are safety and a positive atmosphere for learning and developing social skills. Proehlific Park makes every effort to help children understand clear definitions of acceptable and unacceptable behavior.

Proehlific Park does not condone and will not permit:

- Leaving children unsupervised
- Ridiculing, threatening, using an inappropriate loud voice
- Use of profanity

A child's behavior is expected to be consistent with the following:

- Cooperate with staff and follow directions
- Use appropriate language at all times
- Respect other children and staff, equipment and facilities, and yourself
- Maintain a positive attitude
- Stay in program areas- running away is not acceptable

DISCIPLINE POLICY

- If a child is unable to comply with the behavior expectations, a conference will be held by the program director with the child. The parent(s)/ guardian will be notified.
- If after the above meeting the child is still unable to comply with the behavior expectations, the program director will set up parent(s)/guardian and the program director.
- If the child's behavior continues to be disruptive and/or unsafe, the child will be subject to suspension or dismissal.
- Failure of the parent(s)/guardian to attend conference(s) and cooperate will subject the child to suspension or dismissal.

Behaviors which may result in immediate dismissal include but are not limited to:

- Any action that could threaten or pose a direct threat to the physical/emotional safety of the child, other children or staff. Prohibited conduct may include, but is not limited to, abusive jokes, insults, slurs, threats, name calling, bullying or intimidation.
- Fighting
- Sexual misconduct
- Possession of a weapon of any kind
- Vandalism or destruction of Proehlific Park property or property of others
- Possession of or use of alcohol or controlled substances unless under the prescription of a doctor
- Running away and/or hiding.
